Introduction

The purpose of the publication is to identify the constitutional provisions and statutes that grant, limit, restrict, or prohibit the exercise of the power of eminent domain and the entity to which each provision applies. Some statutes use the term "condemn" or its derivative to express the concept of eminent domain and are included, as appropriate.

The publication is organized into three tables: Table 1, Texas Constitutional Provisions Relating to the Power of Eminent Domain; Table 2, Texas Statutes Granting, Limiting, or Restricting the Power of Eminent Domain; and Table 3, Texas Statutes Prohibiting the Exercise of the Power of Eminent Domain.

Not every statute referenced in the publication is effective as of publication date. H.B. No. 2619, relating to the nonsubstantive revision of certain local laws concerning special districts, and S.B. No. 1540, relating to a nonsubstantive revision of statutes relating to railroads, enacted by the 81st Texas Legislature, made their provisions effective April 1, 2011. The publication does not distinguish the provisions included in the tables that are affected by these bills; however, the effective date information can be found in the text of the hyperlinked statute. Although Chapter 21, Property Code, neither grants nor prohibits the exercise of the power of eminent domain and is not referenced in a table in the publication, the chapter may be of interest to the reader because it outlines the procedures for exercising the power, including the procedures for determining the value of property.

Noncodified Special Purpose Districts

The publication includes only those entities whose eminent domain power is addressed in the Texas Constitution and Texas statutes. The legislature has created numerous special districts whose governing authority exists only in session law; information on these districts is not included in the publication. Over the next several years, these special district local laws will be identified and codified through the Texas Legislative Council's ongoing statutory revision project. Some of these entities may have or may be denied the power of eminent domain.

There also exist special districts, such as hospital and water districts created under general law authority by counties and water districts created by the Texas Commission on Environmental Quality, whose governing provisions are not placed in statutory law; information on these districts is not included in the publication. There are a few instances where the legislature has enacted a statute that addresses such a special district on a specific matter. If the matter addressed in statute were the district's eminent domain power, the entity and its relevant statute would be included in the publication. There is no such instance in the publication.

Explanation of Tables

Table 1 includes each constitutional provision relating to eminent domain arranged in article order (column one) and the entity to which each provision applies (column two). Each provision citation contains a hyperlink to the text of the provision on the Texas Constitution and Statutes website maintained by the Texas Legislative Council.

Table 2 includes each statute that grants, limits, or restricts the power of eminent domain arranged in code then section order (column one) and the entity to which each statute applies (column two). In the table, some entries include two statute citations, one of which grants the power of eminent domain and the other of which limits its exercise in some way, e.g., to a particular purpose or to a particular geographic area. Also in the table, some governmental entities, such as a county and a municipality, because of their range of activity, have multiple entries referencing statutes that address the entity's power of eminent domain.

Each statute citation contains a hyperlink to the text of the statute on the Texas Constitution and Statutes website with the following exception. Certain types of special purpose districts that are codified in the Special District Local Laws Code may be granted the power of eminent domain by reference to general law. For example, Chapter 49, Water Code, relating to a general law water district, and Chapter 505, Local Government Code, relating to a Type B corporation, each confer the power of eminent domain on a district that is created under its provisions. Although the table includes a citation to the statute that contains the referential grant of power, it does not provide a hyperlink to the text of such a statute.

Table 3 includes each statute that expressly prohibits an entity from exercising the power of eminent domain arranged in code then section order (column one) and the entity to which the statute applies (column two). The entities referenced in the table do not have the power of eminent domain for any purpose. Each statute citation contains a hyperlink to the statute text on the Texas Constitution and Statutes website with the following exception. In some instances, an entity is subject to a general law that includes the power of eminent domain, but is prohibited from exercising the power. Although the table includes a citation to the statute that subjects the entity to such a general law, the table does not provide a hyperlink to the text of the general law statute.
